Under the provision of A.R.S. 39-121, Public Records Law, it is requested that the Maricopa County Sheriff's Office release the below indicated Departmental Report and/or Record.

If you are the victim of a **crime** per A.R.S. 39-127, the Maricopa County Sheriff's Office will provide one free copy of the report to you or your immediate family. For the purpose of this release, immediate family is defined as: spouse, parent, child or legal guardian. If you are not listed as the Victim, you may be subject to a fee for a copy of the incident report. Traffic accident reports are not subject to ARS 39-127, unless it has been proven intentional.

Your request may be denied if the report is not complete or if it is determined that its release may hinder prosecution. Your request will be denied if the report was not authored by the Maricopa County Sheriff's Office.

The fee for all Incident Reports is \$5.00 for the first 10 pages and \$.50 per page thereafter. All other requests must be made through the Legal Liaion Section located at the Maricopa County Sheriff's Office Headquarters.
